The Section 809 Panel, created in section 809 of the FY16 National Defense Authorization Act (NDAA) and amended by section 863(d) of the NDAA for FY17, is tasked with streamlining and improving the defense acquisition process.

Our panel consists of 18 commissioners who are senior marketplace and government leaders with more than 350 years of collective experience. The panel has two years to develop recommendations for change in the regulation and associated statute.
